RULES AND REGULATIONS

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. VOID WHERE PROHIBITED.

OPEN ONLY TO LEGAL RESIDENTS IN CALIFORNIA, AND OREGON

18 YEARS OF AGE OR OLDER.

1. **PARTICIPATION:** By completing the entry form to enter the Gift Giveaway promotion (the "Promotion") and providing your valid contact information for the Promotion you are officially entered into this Promotion and you agree to be bound by the following rules (the "Official Rules"), which constitute a binding agreement between you, on one hand, and Wave Broadband on the other hand (the "Sponsor"). These Official Rules apply only to this Promotion and not to any other sweepstakes or contests sponsored by Sponsor or any of their respective affiliates.

Employees of Sponsor and their immediate families (spouses, parents, children, siblings, and their respective spouses), including household members of Sponsor's employees are not eligible to enter.
